




PSOTC GENERAL INFORMATION



BASIC INFORMATION

The Peace Support Operations Training Centre (PSOTC) is offering resident and non-resident courses divided into three different areas – officer's courses, NCO courses, and wider security section courses. Resident courses are held at the PSOTC premises located at Camp Butmir in Sarajevo. Non-residents courses are offered to partner nations in accordance with their needs for specific topics. Non-resident courses are regulated by the PSOTC Mobile Training Team, and depending on topics can be conducted in cooperation with partner institutions.

PORTFOLIO OF COURSES

PSOTC, as an internationally recognized centre, is offering courses accredited/certified by NATO, UN, and EU as well as University accredited per Bologna Process. In accordance with expressed needs of different entities, the courses are offered to all three components: military, police, and civilians.

PLATFORMS AVAILABLE

The list of PSOTC courses is available through different means:

- First of all, the courses are listed in the PSOTC catalog with all explanations regarding a specific course. The course catalog is available on the PSOTC website or as a printed version of it.
- All NATO-certified courses are listed on ePrime and ETOC, NATO platforms for all education events with NATO
 certification.
- Invitation letters for every course offered by PSOTC are being sent to partner nations through POC in their respective institutions and/or diplomatic mission.

HOW TO APPLY

The number of seats, as well as candidate criteria for every course, are defined in advance. Depending on the status of course participation, the status of course candidates can be defined as a subsidized, sponsored, or non-sponsored basis. For those who are sponsored or subsidized the number of course participants is predefined and guaranteed. The rest of the seats are available on a first-come/first-served basis and it is not limited to one person from a specific country/organization only. Courses are offered through NATO online platforms as well (ePrime and ETOC). Applying to those courses is available directly through national/organization POC. It is available only to those who are predefined by NATO as a NATO member or NATO partner.

In basics, PSOTC is sending an invitation letter 90-120 days prior to the course start. An invitation letter is stating basic information regarding the course. As an annex, administrative instructions are defining all necessary info (accommodation, meals, services, requirements, etc.) The type of invitation letter depends on if the invitees are defined as subsidized, sponsored, or non-sponsored. After applying, a nomination letter from the official sending authority is requested. Refer to the PSOTC website https://psotc.org/ in order to define how to apply for the specific course.

LEARNING RESOURCES AND STUDENT SUPPORT

The PSOTC is located at Camp Butmir in Sarajevo, Bosnia and Herzegovina. It is a modern and well-equipped training centre with five syndicate rooms designed for eight people each, three additional syndicate rooms designed for 12 people each, a lecture hall designed for 60-80 people, a modern library, a conference room, and a students' common room. Single-room accommodation for students is provided at the Camp Butmir accommodation block. Accommodation outside of Camp Butmir can be arranged as well. Accommodation for non-sponsored students is their own responsibility. Be aware of PSOTC's recommendation in order to have transportation provided.

The PSOTC can provide all students with a laptop with a local area network and 24 hrs access to public internet inside Camp Butmir.

COURSE DESCRIPTION

The international Staff Officers Skills Course (ISOSC) has been designed to serve as essential preparation for individuals who will be posted in multinational HQ. Further training is required to prepare them for specific staff positions.

COURSE AIM

The aim of the course is to develop essential staff skills of junior officers in accordance with NATO standards, as basic preparation for their engagement in international and national headquarters (HQs).

LEARNING OBJECTIVES

- Comprehend NATO challenges in conducting current operations;
- Conform to working in a multinational working environment;
- Comprehend the system of democratic control over the armed forces;
- Use IT technologies as tools in staff work;
- Apply basic NATO military symbols for land operations, maps, and land navigation;
- Use NATO voice procedures in radio communications in the English language;
- Use NATO reports and returns in multinational operations.

COURSE PARTICIPANTS

- Up to 30 participants;
- Military officers (OF-1 to OF-2) including all services. The course is designed for officers deployed at battalion HQ and above in national posts or the multinational environment;
- Participants should be nationally trained in the military decision-making process or have working experience as staff officers in a national HQ;
- Participants have to have at least 2, 2, 2, 2 of proficiency in English (as prescribed by STANAG 6001) or approximately B1 level in accordance with the Common European Frame (CEFR).

The course is delivered by national and international instructors and subject matter experts.

COURSE DESCRIPTION

The Counter-Insurgency Orientation Course is designed and delivered to assist trainers and leaders with the doctrine, mindset, and methodologies of counterinsurgency operations.

COURSE AIM

The aim of the course is to introduce key leaders and trainers to concepts and doctrines related to counterinsurgency operations in order to create a framework for an understanding of the differences between counterinsurgency and conventional warfare and introduce COIN definitions and principles.

LEARNING OBJECTIVES

- Analyze operational environment and effects of the environment on NATO operations;
- Understand insurgency dynamics and strategies;
- Understand COIN fundamentals:
- Understand the relationship, roles, and tasks of the multiple actors involved in defeating the insurgency;
- Understand COIN Intelligence Preparation of Environment (IPE) and Military Decision Making Process (MDMP) required to integrate political, military, social, and economic programmes and actors to achieve stability and reduce insurgent influence;
- Understand unique features of leadership in COIN operations.

- Up to 40 participants;
- Military officers (OF-1 OF-4) and NCOs (OR-7 OR-9) including all services;
- Participants are preferably selected trainers and key leaders who will be deployed in COIN operations;
- Participants have to have at least 2, 2, 2 of proficiency in English (as prescribed by STANAG 6001) or approximately B1 level in accordance with the Common European Frame (CEFR).

COURSE DESCRIPTION

The Building Integrity in Peace Support Operations Course (BIPSOC) is developed in order to help raise awareness, sustain change and produce long-term benefits in response to reducing corruption and enhancing the professionalism and effectiveness of all military, police, or civilian servants across the relevant national and NATO structures/missions, through the transfer of gained knowledge, tools, and techniques.

COURSE AIM

The aim of the course is to raise awareness and share practices, tools, and techniques that enable participants of the course to recognize, understand and counter various types of corruption which undermine the credibility of an organization and mission success in multinational peace support operations.

LEARNING OBJECTIVES

- Estimate the fundamentals of Building Integrity (BI) and its importance for personal behavior and professionalism;
- Restate the National/International Legal Anti-Corruption Framework as well as NATO anti-corruption efforts in NATO-led operations and missions;
- Paraphrase corruption risks and integrity challenges in the PSO environment;
- Estimate the subject of corruption in a personal or functional context in the PSO environment.

COURSE PARTICIPANTS

- Up to 40 participants;
- Military officers (OF-2 OF-4), military NCOs (OR-7 OR-9) including all services, and police and civilian equivalents;

The Building Integrity for Senior NCO Course (BISNCOC) is designed and developed in response to the educational deficit and in order to contribute to the continuous professional development of NATO/partner personnel, which in turn will promote change and build nations' integrity capacity through the transfer of knowledge and development of skills.

COURSE AIM

The aim of the course is to raise awareness of corruption and promote integrity by strengthening the leadership and management skills of the Senior NCOs in order to enhance their professionalism, competency, and effectiveness in the national and multinational working environment.

LEARNING OBJECTIVES

- Consider the subject of corruption, its nature, and its prevalence in a personal, functional, and political context:
- Summarize major domestic and international organizations involved in anti-corruption activities;
- Follow measures for reinforcement of personal conduct;
- Identify corruption risks within procurement and disposal processes;
- Identify integrity challenges in PSO;
- Summarize current best practices and anti-corruption measures in PSO.

COURSE DESCRIPTION

Although distinct nations are responsible for their pre-deployment training continuum, it is vital that staff officers and NCOs in tactical units are trained in the NATO approach to conducting peace support operations (PSO). Given the multinational and joint character of PSO, coherence, and interoperability between nations contributing troops to PSO have to be enhanced. Therefore, education and pre-deployment training of all military personnel on NATO doctrines, standards, and procedures for conducting PSO are imperatives for all nations contributing personnel to NATO-led PSO.

COURSE AIM

The aim of the course is to prepare nationally trained staff officers and NCOs for assignments in multinational tactical level HQ conducting NATO-led peace support operations (PSO).

LEARNING OBJECTIVES

- Explain the main elements of the conduct of NATO operations;
- Explain the fundamentals of NATO-led peace support operations (PSO);
- Describe the basics of NATO-led peace support operations (PSO) techniques and procedures;
- Explain the legal framework of NATO-led peace support operations (PSO);
- Explain the protection of civilians (POC) concept in peace support operations (PSO);
- Explain the role of the military in child protection (CAAC) in peace support operations (PSO);
- Explaining gender mainstreaming and the role of the military in response to CRSV in peace support operations (PSO);

- Manage information flow in a Tactical Operations Centre (TOC) in peace support operations (PSO).

- Participants have to have at least 2, 2, 2, 2 of proficiency in English (as prescribed by STANAG 6001) or approximately B1 level in accordance with the Common European Frame (CEFR).

The course is delivered by national and international instructors and subject matter experts. It is conducted under the supervision and with assistance from Nordic Centre for Gender in Military Operations (NCGM).

The Essential Staff NCO Skills Course (ESNCOSC) provides insight into lower-level staff organization and procedures in NATO-led operations. 

- Restate the national/international legal anti-corruption framework as well as NATO anti-corruption efforts in NATO-led operations and missions;
- Paraphrase corruption risks and integrity challenges in the PSO environment;
- Estimate the subject of corruption in a personal or functional context in the PSO environment.

COURSE PARTICIPANTS

- Up to 40 participants;
- Military officers (OF-1 OF-4) and NCOs (OR-7 OR-9), and police and civilian equivalents;
- Participants have to have at least 2, 2, 2, 2 of proficiency in English (as prescribed by STANAG 6001) or approximately B2 level in accordance with the Common European Frame (CEFR).

This course is based on the resident BI in PSO Course (ePrime: ACT.646; ETOC: BIT-BI-25657). The course is delivered by national and international instructors and subject matter experts.

COURSE DESCRIPTION

The UN Comprehensive Protection of Civilians Course (UNCPOCC) provides an understanding of the Protection of Civilians within the UN peace operations framework through lectures, syndicate discussions, and scenariobased exercise (SBE). In addition to POC, emphasis will be placed on Gender and Child Protection in peace operations and the Prevention of Sexual Violence.

COURSE AIM

The aim of the course is to provide the key personnel from tactical HQs deploying on UN peace operations with a framework for understanding the impact of Protection of Civilians (POC), Child Protection, and Conflict-Related Sexual Violence (CRSV) on the tactical planning level within UN Peacekeeping, and how to integrate military and other agencies' protection efforts in multidimensional UN peace operations.

LEARNING OBJECTIVES

- Comprehend POC conceptual framework and challenges for its implementation in the UN peace operations environment;
- Identify the key components of the legal framework that supports the POC concept;
- Implement the POC concept in the operational planning process;
- Comprehend special considerations for Conflict-Related Sexual Violence (CRSV) and Child Protection (CP).

COURSE PARTICIPANTS

- Up to 40 participants;
- Military officers (OF-1 OF-4) and NCOs (OR-8 OR-9) including all services, as well as police and civilian equivalents selected to be deployed as peacekeepers in UN peace operations;
- Course participants should have basic knowledge about United Nations, preferably completed UN Staff Officer Course, UN Military Observers Course, and UN Police Officers Course;
- Participants have to have at least 2, 2, 2, 2 of proficiency in English (as prescribed by STANAG 6001) or approximately B2 level in accordance with the Common European Frame (CEFR).

REMARKS

This course is based on the residential UN Comprehensive Protection of Civilians Course (ePrime: PSOTC.6; ETOC: MCP-CM-35692). The Course is delivered by national and international instructors and subject matter experts.

COURSE DESCRIPTION

The Utility of Gender in PSO Course (UGPSOC) was developed to increase awareness and provide a conceptual understanding of gender issues in the security sector. It has a particular focus on peace support operations (PSO) and how peace support force (PSF) should understand women's needs and their role as actors within the society they are tasked to protect.

COURSE AIM

The aim of the course is to provide participants with an understanding of applying a gender perspective in the security sector and the importance of the application of gender perspective on peace support operations, as well as of the prevention of sexual violence in conflict.

LEARNING OBJECTIVES

- Illustrate international framework and guidelines related to gender mainstreaming in PSO;
- Explain the importance of gender perspective implementation through all phases of PSO;
- Exemplify implementation of a gender perspective in all functional areas;
- Explain the importance of addressing CRSV;
- Summarize measures to address CRSV.

COURSE PARTICIPANTS

- Up to 40 participants;
- Military officers (OF-1 OF-4) and NCOs (OR-5 OR-9) including all services, police, and civilians (mid-level decision makers);
- Participants have to have at least 2, 2, 2 of proficiency in English (as prescribed by STANAG 6001) or approximately B2 level in accordance with the Common European Frame (CEFR).

REMARKS

This course is based on the resident NATO-approved Utility of Gender in PSO Course (ePrime: ACT.653; ETOC: GEN-GO-21324). The Course is delivered by national and international instructors and subject matter experts.

ACCOMMODATION

The cost of accommodation depends on the place of accommodation (camp or hotel). Participants will be advised separately as each course has different requirements depending on specific arrangements (sponsored, subsidized, or own responsibility). PSOTC is providing accommodation for the students at Camp Butmir with single study bedrooms and a common lavatory and showers. All necessary bedding is provided but **toiletries and towels are not provided**. The cost is 9 (nine) Euros per day/per student.

Booking of accommodation outside of Camp Butmir is possible. For convenience, PSOTC will advise where to book accommodation in order to organize daily transportation from/to camp Butmir. The cost of the hotels outside of the Camp is on a commercial basis.

SERVICE INFORMATION



MEALS

Meals are available inside Camp Butmir at the Dining Facility (DFAC) and two snack bars. Some restaurants are available in the vicinity of Camp Butmir. Participants will be advised separately as each course has different requirements depending on specific arrangements (sponsored, subsidized, or own responsibility). The cost of meals in DFAC is calculated 7 (seven) Euros per meal.

RULES OF CONFIDENTIALITY

The "Chatham House Rule" of confidentiality is applied in PSOTC. The meaning to the participants is being explained at the beginning of the course. The participants of the course are invited to conduct an open discussion.

Refer to Chatham House Rule

"Participants are free to use the information received during the course, but neither the identity nor the affiliation of the speaker(s), nor that of any other participant, may be revealed".

SECURITY PROCEDURES

Access: Camp Butmir is run by elements of EU Forces in Bosnia and Herzegovina; therefore, special procedures are in place in order to enter the Camp. It is mandatory to send **a copy of the participant's passport** so that PSOTC can apply for his/her access card to Camp Butmir.

The copy of the passport should be scanned and sent out together with the online application form through the link provided. Please also note that access cards to Camp Butmir are needed for access to restaurant DFAC (lunch).

Within the camp, participants have to carry their passports (the number of which has to be the same as the one provided to the PSOTC).

Laptops: Participants are not allowed to bring their individual laptops into the Camp. This is due to the Camp HQ EUFOR procedures and security regulations. However, PSOTC computers with internet access will be available in the syndicate rooms for the whole period of the course duration.

TRANSPORTATION

Participants will be advised separately as each course has different requirements depending on specific arrangements (sponsored, subsidized, or own responsibility).

PSOTC will organize (if not specified differently in the administrative instructions) transportation from/to the Sarajevo airport or bus/train stations to the accommodation location.

PSOTC will organize daily transportation from/to a specific hotel recommended in the course administrative instructions to Camp Butmir in accordance with course schedules. Transportation from other locations will not be provided by PSOTC and will be the responsibility of the course participants.

Please note that the parking lot is provided in front of Camp Butmir.

MEDICAL SERVICE

PSOTC does not cover any health care expenses. All participants are responsible for ensuring to be in possession of valid and adequate insurance (accident, repatriation, liability, and health). Medical facilities at the Camp as well as medical facilities in Sarajevo are available for emergency purposes only.

VISA REQUIREMENTS

In order to check the status of your respected country related to visa necessity, please refer to the official website of the Ministry of Foreign Affairs of Bosnia and Herzegovina concerning visa requirements for a specific country.
